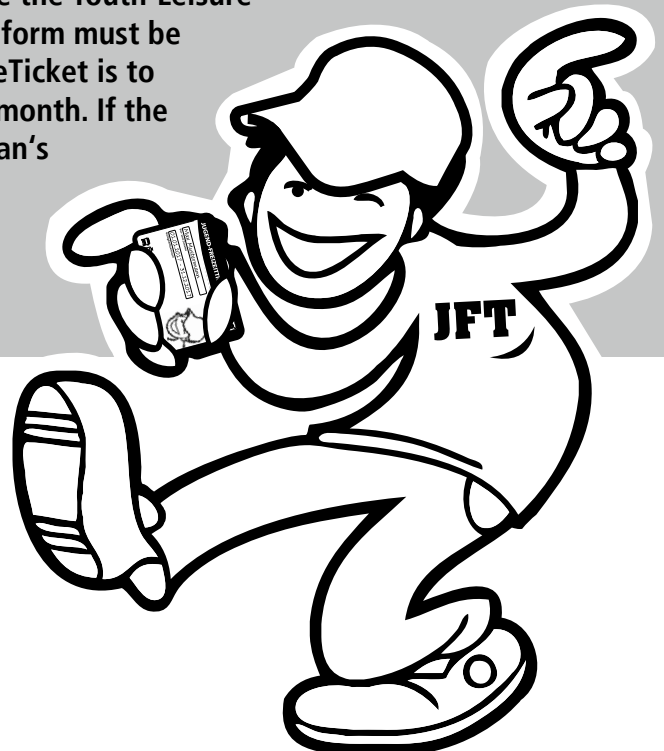

GENERAL TERMS AND CONDITIONS FOR THE YOUTH LEISURE TIME TICKET

Status: 01/01/2019

1. General Information

1. The Youth Leisure Time (JFT) Ticket is a special offer for adolescents and young adults under 21 years of age. It is issued as a monthly or annual ticket and is not transferrable.
2. The Youth Leisure Time Ticket entitles the ticket holder to travel all day throughout the entire VBN network Monday to Friday (including school holidays) from 02:00 PM to 03:00 AM the following day, on Saturdays, Sundays and national holidays as well as Christmas Eve and New Year's Eve. Taking along additional passengers is not permitted.
3. The BSAG night lines operating within VBN, the VWG night express line and the Nachtschwärmerlinien (all lines marked with "N") may be used without paying surcharges and Nachteulen Ammerland is free of charge after 03:00 AM.
4. The Youth Leisure Time Ticket may only be used for travelling 2nd class on the trains operating within the VBN network. Upgrading to 1st class is not possible even by paying the surcharge. Travelling on the IC/EC trains within the VBN network is excluded, with the exception of the route Bremen Hbf (main train station) – Augustfehn.

The Youth Leisure Time Ticket - Monthly Ticket

1. The ticket holder must write his name on the monthly Youth Leisure Time Ticket. Upon request, the entitlement must be verified; up to 16 years of age, via a valid student or children's ID featuring an image, from 16 years of age via a government issued photo ID.
2. The ticket holder may not be 21 years old at the beginning of the validity period.
3. The monthly ticket may be purchased at intercompany customer service centres, privately owned pre-sale agencies, Deutsche Bahn travel centres as well as the transportation companies' automated vending machines and ticket printers. The tickets are not sold on board of the transportation vehicles of the BSAG, BREMERHAVEN BUS and the VWG.
4. If the monthly ticket is lost or damaged, it will not be replaced.

The Youth Leisure Time Ticket – Annual Ticket

1. The annual Youth Leisure Time Ticket is issued at the customer service centres of the BSAG, BREMERHAVEN BUS and the VWG in form of a plastic card. The annual ticket is generally sent out by post.
2. It is issued at the first of each month for the duration of 12 months. Premature cancellation is not possible.
3. An order form must be completed to obtain the annual ticket; the order form must be signed by the party placing the order and, for persons under the age of 18, by their legal guardian. The order form and a current passport picture of the future ticket holder must be sent to one of the transportation companies listed. Photo copies or poor quality passport pictures will not be accepted. The ticket holder may not be 21 years old at the beginning of the validity period. Upon request, entitlement must be verified, up to 16 years of age, via a valid student or children's ID featuring an image, from 16 years of age via a government issued photo ID.
4. Order forms are available from the VBN transportation companies and on the homepage at www.vbn.de.
5. The annual fee must be transferred to the applicable transportation company in full. Cash payment is accepted in participating customer service centres. After the payment has been received and the order form has been submitted, the name image of the ticket holder will be printed on the ticket and the ticket will be mailed to the ticket holder.
6. The order form and payment must be received by no later than the 10th of the month; thereafter the ticket will be posted to the ticket holder effective the following month on a timely basis.
7. This shall apply for extending the annual ticket as well.
8. A re-issue may be requested if the annual ticket is lost. The replacement ticket is subject to a fee of €15.00. The amount must be paid either in cash at the customer service centre or via bank transfer to the applicable transportation company without further request. The replacement ticket will be issued within 5 business days.

Thereafter, the currently valid tariff and transportation regulations of the Verkehrsverbund Bremen/Niedersachsen (VBN) shall apply.
